Their Excellencies and I have done a review of the Baronial General and Financial Policies, and have determined that there are a few changes that need to be made.

I am posting the proposed changes for the populace to look over, and make any comment they wish. At Birthday of the Dragon, held April 18, 2020, there will be a populace meeting to discuss these changes and vote on making them a permanent part of the General and Financial Policies. If you have any questions or comments, please feel communicate them to Their Excellencies and myself in advance of the meeting, if possible.

Financial Policy for the Barony of Nottinghill Coill

Section 1.3

Currently Reads

"This document shall be reviewed annually at the Baronial Meeting at the Baronial Birthday event"

Proposed Change

"This document shall be reviewed annually at an event within the Barony"

Reasoning

This removes the restriction of reviewing at a specific event, and gives a little leeway to when the Financial Policy can be reviewed. Baronial Birthday is a very busy and hectic day for Their Excellencies, so this will give a little breathing room.

Section 2.2

Currently Reads

"The Exchequer shall, upon request, provide access to the Barony's financial reports and books to any member of the Barony and shall publish the annual Doomsday Report in the February issue of the Baronial Newsletter"

Proposed Change

"The Exchequer shall, upon request, provide access to the Barony's financial reports and books to any member of the Barony. The Comparative Balance Statement and Income Statement shall be published in the February issue of the Baronial Newsletter"

Reasoning

This is an area that we have not been compliant in for several years, and needs to be addressed. There really is no need for the entire Doomsday report to be published, but the SCA Financial Policy does state:

"Financial statements (consisting of the Comparative Balance Statement and the Income Statement) must be made available to the public at least annually, whether published in a newsletter or distributed to the membership in some other form." – SCA Financial Policy (Approved 8/27/2019), Section I, part C.

Therefore, we are proposing that the text be changed from Doomsday Report to a simple Comparative Balance Statement and Income Statement.

Section 3.6

Currently Reads

"The Financial Committee shall report all of its activity to the populace at the next scheduled Baronial meeting and in the Baronial newsletter"

Proposed Change

"The Financial Committee shall report all of its activity to the populace at the next scheduled Baronial meeting."

Reasoning

A report during a regular Baronial Meeting should be sufficient.

Section 4.1.1

Currently Reads

"The Event Steward shall present a proposed budget for an event to the Financial Committee for review and approval at least six (6) months before the date of the event. The Financial Committee may choose to reduce this six (6) month schedule under extenuating circumstances, such as a request from the Crown or an event being small enough in scope that six (6) months' lead time is not required. A final itemized budget shall be presented not later than ninety (90) days before the start of the event."

Proposed Change

"The Event Steward shall present a proposed budget for an event to the Financial Committee for review and approval at least six (6) months before the date of the event. The Financial Committee may choose to reduce this six (6) month schedule under extenuating circumstances, such as a request from the Crown or an event being small enough in scope that six (6) months' lead time is not required. A final itemized budget shall be presented not later than thirty (30) days before the start of the event."

Reasoning

With the speed of communications, it is felt that thirty days should be sufficient.

Section 4.2.1

Currently Reads

"All checks shall be photocopied and deposited in a timely manner, within not more than two (2) weeks of receipt."

Proposed Change

"All checks shall be photocopied, scanned, or photographed and deposited in a timely manner, within not more than two (2) weeks of receipt."

Reasoning

Adding additional methods, since much is digital these days.

Section 4.2.3

Currently Reads

"All event proceeds shall be deposited within five (5) days after the conclusion of the event."

Proposed Change

"All event proceeds shall be deposited within seven (7) days after the conclusion of the event."

Reasoning

This gives a little leeway to allow for things such as travel, vacations, or holidays messing with scheduling.

Section 5.1.2

Currently Reads

"Requests for reimbursement of event-related expenditures must be submitted within five (5) days of the close of the event and must have the approval of the Event Steward."

Proposed Change

"Requests for reimbursement of event-related expenditures must be submitted within seven (7) days of the close of the event and must have the approval of the Event Steward."

Reasoning

This gives a little leeway to allow for things such as travel, vacations, or holidays messing with scheduling.

These changes have been sent to the Kingdom Exchequer on 02/25/2020 for approval that they comply with Kingdom and Corporate policies. Should the Kingdom exchequer respond with additional changes, these will be published immediately so as to solicit input from the Baronial Populace prior to the meeting in April.

General Policy for the Barony of Nottinghill Coill

Version 04.15.2017

1. The Barony

1.1. The Barony of Nottinghill Coill is a region within the Kingdom of Atlantia, being one of the Laurel Kingdoms of the Society for Creative Anachronism. For the purposes of these policies, the Barony of Nottinghill Coill shall be defined by, but is not limited to, all those geographical regions specified by corpora and Atlantian Law.

2. The Policies

- 2.1. The Barony of Nottinghill Coill, as defined by Corpora, has written the following set of Baronial Policies where were approved by the Populace at the 04/15/2017 Business Meeting
 - 2.1.1.In all cases, these Baronial Policies shall be consistent with Corpora and Atlantian Law. If such conditions should arise where there may be a conflict, Kingdom Laws of Atlantia shall always supersede these policies. This set of policies shall be amended from time to time to confirm to both Corpora and Atlantian Law.
 - 2.1.2.The Nottinghill Coill Baronial Policy shall be reviews within the first six months after the investiture of new Coronets, and a copy maintained by the Baronial Seneschal.
- 2.2. The Baronial policies can be amended or altered by the Barony of Nottinghill Coill at any time, provided:
 - 2.2.1.All proposed changes to the Baronial policies shall be published in the Baronial newsletter at least fourteen (14) days prior to the meeting in which they will be discussed and/or voted upon.
 - 2.2.2.No changes shall be made or acted upon without approval at a Baronial meeting as defined by 4.6 of this Policy.
 - 2.2.3.Approved changes shall not be effective until such time as they are published in the Baronial newsletter.
 - 2.2.4. These Baronial Policies shall be maintained on the Baronial web page.

3. The Baronial Coronet

- 3.1. The Baronial Coronet shall be defined as the individual(s) appointed by the Crown of Atlantia.
- 3.2. The Baronial Coronets' term shall be in compliance with Atlantian Law.
- 3.3. The appointment of a new Baronial Coronet shall be conducted in accordance with Atlantian Law.

4. Baronial Meeting

- 4.1. A Baronial meeting is any assemblage of the populace which is called by the Baronial Cornet or Baronial Seneschal in order to receive advice on the administration and governance of the Barony or for the populace to vote on such issues as are required by policies.
- 4.2. The meeting agenda and the actual running of said meeting is the responsibility of the Baronial Seneschal.

- 4.3. The date, time, and place for the Baronial meeting shall be published in the Baronial newsletter and posted on the Baronial e-list at least fourteen (14) days prior to its commencement.
- 4.4. A tentative agenda should be published va the Baronial e-list seven (7) days prior to the scheduled meeting. Members of the populace may request topics for discussion or vote by writing the Baronial Seneschal.
- 4.5. Between scheduled Baronial meetings, emergency meetings of the Baronial Financial Committee may act in the Barony's best interests. Such actions will be reported at the next regularly scheduled Baronial meeting and/or in the next scheduled Baronial Newsletter of Baronial Email list.
- 4.6. When a vote is required, members of the Barony are defined as SCA paid members who reside or participate within the geographic boundaries of the Barony. All votes shall be decided by simple majority.

5. Baronial Officers

- 5.1. Duties of the offices of the Barony of Nottinghill Coill are specified in Corpora, Kingdom Law, Baronial Financial Policy, and this document. Baronial offices may consist of, but are not limited to:
 - Seneschal (required by Corpora)
 - Exchequer (required by Corpora)
 - Herald (required by Corpora)
 - Chronicler (required by Corpora) (Additional Duties: The Baronial Chronicler, or an acceptable deputy designated by the Chronicler, shall be responsible for taking the minutes at Baronial meetings, and shall publish the meetings in the next Baronial newsletter)
 - Knight's Marshal
 - Minister of Arts and Sciences
 - Minister of the Lists
 - Chancellor of Youth
 - Chatelain(e)
 - Webminister (Additional Duties: The Webminister shall publish the Baronial Newsletter to the Baronial website within five (5) days of receipt of the same from the Baronial Chronicler.)
- 5.2. Each Baronial Officer shall report on the state of his/her office at each Baronial meeting. Each Baronial officer is required to attend at least one Baronial meeting per quarter, if such meeting is scheduled, to give the Officer's Report at the meeting. Noncompliance with this policy may results in a recommendation for removal of the individual being forwarded to the appropriate Kingdom officer.
- 5.3. All papers (including official correspondence) and regalia belonging to any office are the property of that office and must be transferred in their entirety to any new Baronial officer within thirty (30) days of any change of office.
- 5.4. Appointment of Baronial officers
 - 5.4.1. The opening of the Baronial Office shall be made public by an announcement at a scheduled Baronial meeting, in a written announcement in the Baronial Newsletter, and on the Baronial e-list.

- 5.4.2. Announcements shall include a deadline for consideration to assume the duties of an Office no less than fourteen (14) days from the date the opening is announced in all required venues.
- 5.4.3. Interested candidates shall respond in writing to the Baronial Seneschal, and Baronial Coronet.
- 5.4.4.At the deadline, the list of candidates shall be published on the Baronial e-list and website, inviting written, private commentary from the populace to the Baronial Seneschal and the Baronial Coronet. All such commentary shall remain confidential
- 5.4.5.The Baronial Seneschal and the Baronial Coronet wil review the commentary and together select the candidate and recommend such to the Kingdom officer for warranting.
- 5.4.6.At such time as the warranting Kingdom officer allows, the new Baronial officer shall be publicly announced via the newsletter and website.
- 5.4.7. Due to the length of the Pennsic War, no officer changes shall be made during the duration of that event.
- 5.5. Baronial officers may select whatever deputies they require for the duration of their office.
- 5.6. Baronial Officer Term Limits shall be as follows: Baronial officers can serve no more than two (2) consecutive terms unless otherwise permitted in the Atlantian Book pf Policy. Term lengths, both initial and subsequent, are as defined for each particular office in the Atlantian Book of Policy. This may be extended in cases where no one steps up to fill a pending slot.
- 5.7. Any office not required to maintain Baronial status may go vacant.
- 5.8. In the event that an office suddenly becomes vacant, the outgoing officer's primary ("Drop Dead") deputy may assume the office at the discretion of the Seneschal on an interim basis until the requirements are met for filling the office vacancy.
 - 5.8.1.Officers who do not attend three consecutive meetings or make arrangements for the office report to be given at said meetings may be recommended to their respective Kingdom Officer for removal.
 - 5.8.2.Officers in non-compliance with their Society, Kingdom, or Baronial laws or policies may be recommended to their respective Kingdom Officer for removal. The Seneschal shall attempt to contact the Baronial Officer prior to the recommendation.

6. Publications

- 6.1. All Baronial publications should go through the Baronial Chronicler's office.
- 6.2. The Barony shall publish a monthly newsletter in accordance with Kingdom Law.
 - 6.2.1. The Newsletter shall be called The Quill.
 - 6.2.2. The Quill shall be made available on the Baronial web page.
- 6.3. All Letters of Intent for consideration for territorial Baronage shall be published in the Quill.

7. Baronial Events

- 7.1. Any SCA, Inc. approved entity, household, or guild, may sponsor Baronial events in accordance with Baronial Financial Policy.
- 7.2. Nottinghill Coill Baronial General Policy shall conform to Nottinghill Coill Financial Policy in all matters regarding events and budgets.

7.3. Event Steward Selection

- 7.3.1.A prospective Event Steward ("Autocrat") shall submit a bid which includes an Event Proposal form, a Budget, and Proof of Membership through the dates of the event, to the Baronial Seneschal and Exchequer.
- 7.3.2.If there are multiple bids for the same event or event date, the event proposals will be presented to the populace at a Baronial Meeting. The majority vote will determine the Event Steward. Prospective bids may be withdrawn at any time before this vote occurs.

7.4. Event Steward Removal

- 7.4.1.If it is determined by the Seneschal and a majority vote of the Financial Committee that the Event Steward for a Baronial Event is in willful non-compliance with Society, Kingdom, or Baronial Laws or Policies, then the Event Steward will be removed as Event Steward for the event.
- 7.4.2.If an Event Steward is removed from his/her duties, the Baronial Seneschal will serve as interim Event Steward for the event until a new Event Steward is selected.
- 7.4.3.If an Event Steward is removed from duty, a new Event Steward will be selected through vote of the Baronial Officers.
- 7.4.4.If, in case of Emergency, an Event Steward is unable to perform their duties, the Baronial Seneschal will serve as the interim Event Steward until a new Event Steward is selected.
- 7.5. An event's staff shall be selected by the Event Steward.
 - 7.5.1.All event staff must be in compliance with Society, Kingdom, and Baronial Laws and Policies.

8. Baronial Property

8.1. Nottinghill Coill Baronial Policy shall conform to the Nottinghill Coill Financial Policy in all matters regarding Baronial Property.

9. Waiving General Baronial Policy

- 9.1. Any part of this policy may be waived under special or extreme circumstances by approval of the Coronet, Baronial Seneschal, and a third Baronial Officer, with a full accounting to be given at the next scheduled Baronial meeting and in the Baronial Newsletter.
- 9.2. Any part of this policy may be waived by approval by 2/3 of voting members present at a Baronial meeting.

Financial Policy for the Barony of Nottinghill Coill

Version 04.21.2018

1. This Document

- 1.1. This document shall be accepted by a majority vote at a scheduled Baronial meeting and replace all previous financial policies.
- 1.2. This document may be amended or replaced by a majority vote at a scheduled Baronial meeting.
- 1.3. This document shall be reviewed annually at the Baronial meeting at the Baronial Birthday event.
- 1.4. This document is superseded by: Kingdom Exchequer Policy, Kingdom Financial Policy, Kingdom Law, Society Financial Policy, Society Exchequer Policy, Corpora, State and Federal Law.
- 1.5. Unless otherwise stipulated, Nottinghill Coill will follow Atlantian Laws and Policies.

2. The Chancellor of the Exchequer

- 2.1. The Exchequer shall maintain a checking account with appropriate signature cards for the Barony, file all quarterly and event reports as required by Kingdom and Society law and policy, enforce and maintain the Barony's financial policy, serve as chairperson of the Barony's Financial Committee and hold primary responsibility for coordinating with other members of the Financial Committee and communicating the committee's actions to the populace.
- 2.2. The Exchequer shall, upon request, provide access to the Barony's financial reports and books to any member of the Barony and shall publish the annual Doomsday Report in the February issue of the Baronial Newsletter.
- 2.3. The Exchequer or designated representative shall attend and provide a report at all scheduled Baronial meetings.
- 2.4. The Exchequer shall disburse funds for approved expenditures in a timely manner, typically one to two (1-2) weeks, upon presentation of the appropriate receipts.
- 2.5. The Exchequer shall pursue any NSF (Not Sufficient Funds) checks received by the Barony according to the policy outlined in the Society Exchequer's Handbook.

3. Financial Committee

- 3.1. The Financial Committee shall consist of the Exchequer, the Seneschal, and one other officer.
- 3.2. Each member of the Financial Committee must be a paid member of the Society for Creative Anachronism, Inc., be at least 18 years of age, and possess a valid warrant for their office.
- 3.3. Each member of the Financial Committee shall be a signatory on the Barony's checking account.
- 3.4. The Financial Committee shall review all proposed expenditures and may authorize any expenditure of the Barony's unallocated funds.

- 3.5. At the discretion of the Financial Committee, any requested expenditure may be put to a vote of SCA paid members. This is recommended for all expenditures over \$100 that are not event-related.
- 3.6. The Financial Committee shall report all of its activity to the populace at the next scheduled Baronial meeting and in the Baronial newsletter.

4. Events

4.1. Event Budget

- 4.1.1.The Event Steward shall present a proposed budget for an event to the Financial Committee for review and approval at least six (6) months before the date of the event. The Financial Committee may choose to reduce this six (6) month schedule under extenuating circumstances, such as a request from the Crown or an event being small enough in scope that six (6) months' lead time is not required. A final itemized budget shall be presented not later than ninety (90) days before the start of the event.
- 4.1.2. Any changes to the budget must be approved by the Financial Committee.
- 4.1.3.The Financial Committee must authorize any itemized expenditure in excess of the approved amount.
- 4.2. Event Reservations and Registration (Check-In)
 - 4.2.1.All checks shall be photocopied and deposited in a timely manner, within not more than two (2) weeks of receipt.
 - 4.2.2. No funds shall be removed from the Check-In (Gate) cash box except as change for funds received.
 - 4.2.3. All event proceeds shall be deposited within five (5) days after the conclusion of the event.
 - 4.2.4.Certain individuals shall be given complimentary attendance at events hosted by the Barony of Nottinghill Coill. 'Complimentary attendance' includes payment of the event fees, feast fees, and any fees for on-site camping or on-site lodging, as posted in the event flyer. This complimentary attendance only applies to the listed individuals and does not include e.g. other family members, members of Their household, or retainers.
 - 4.2.4.1. The current Landed Baronage of Nottinghill Coill
 - 4.2.4.2. Their Royal Majesties of Atlantia
 - 4.2.4.3. Their Royal Highnesses of Atlantia
 - 4.2.4.4. The incoming Landed Baronage of Nottinghill Coill, at Their Investiture
 - 4.2.4.5. The Autocrat/Event Steward
 - 4.2.4.6. The Feastocrat/Head Cook

4.3. Event Refunds

- 4.3.1. No refunds shall be provided if the event does not make a profit.
- 4.3.2. The Exchequer must receive refund requests in writing no later than seven days after the event.
- 4.3.3.All refunds shall be paid by check from the Barony's checking account.
- 4.3.4. No refund shall be issued until the event books have been closed.

4.4. Event Report

- 4.4.1.The event report shall be completed by the Event Steward and the Exchequer, within two weeks after the conclusion of the event.
- 4.4.2. The event financial report shall be presented to the populace at the next scheduled Baronial meeting after the event books have been closed or by some other means if the next meeting is more than sixty (60) days after the event.

5. Disbursements

5.1. Approved Expenditures

- 5.1.1.Reimbursement for an approved expenditure will be made only upon presentation of a written request for reimbursement and all receipts.
- 5.1.2.Requests for reimbursement of event-related expenditures must be submitted within five (5) days of the close of the event and must have the approval of the Event Steward.
- 5.1.3.Requests for reimbursement of expenditures that are not event- related must be submitted by the end of the quarter following the one in which the expenditure was made.
- 5.1.4.One-time expenditures of less than one hundred dollars (\$100) may be authorized by the Seneschal and Exchequer, and shall be reported at the next Baronial meeting and/or published in the Baronial newsletter if no meeting is scheduled within sixty (60) days of approval of the expenditure.

5.2. Advances

5.2.1.The Financial Committee may approve advance payments to cover anticipated expenditures (such as feast for an event). A written request is required from the recipient prior to disbursement. Receipts and repayment covering the total amount disbursed must be provided within thirty (30) days of receipt of the advance or seven (7) days after the conclusion of the event, whichever is sooner.

6. Subsidiary Branches

- 6.1. Any new group that forms may be given startup money from the Barony in the amount of \$250 or 10% of unallocated funds, whichever is less.
- 6.2. Startup money, as well as other funds belonging to the new group, will be administered by the Baronial Exchequer in accordance with Kingdom Policy.
- 6.3. Until such time as the funds are transferred into the account of the subsidiary branch, that branch will follow the financial policies of the Barony, except that the Financial Committee with consist of the group Exchequer, the group Seneschal, one other group officer, the Baronial Exchequer, and the Baronial Seneschal.
- 6.4. If a subsidiary branch dissolves for any reason, an amount equal to the startup money received from the Barony shall be returned to the Barony's General Fund, if there are sufficient monies in the group account.
- 6.5. Any funds in excess of initial startup monies shall be deposited into the Baronial account within thirty (30) of the dissolution of the subsidiary group.

6.6. The Baronial Exchequer shall report the transfer of funds from any closing group into the Baronial account. This report shall occur within sixty (60) days or at the next scheduled Baronial meeting, whichever is sooner.

7. Inventory

- 7.1. An inventory of Baronial possessions shall be done within ninety (90) days after a Baronial Investiture.
 - 7.1.1.A master inventory shall be maintained by the current Baronage, with copies provided to the Baronial Seneschal and Baronial Exchequer. Updates to the inventory, such as items purchased by or gifted to the Barony, shall be provided to all parties within thirty (30) days of any change.
- 7.2. Baronial possessions shall be defined as any property, depreciable or disposable, purchased by or gifted to the Barony for use by sitting Baronage, Baronial Officers, Baronial Champions, or for general Baronial use (such as a Baronial list field, Baronial tabards, etc.)
- 7.3. Depreciable items are those required to be reported in the quarterly financial reports. These include items such as coronets, Baronial pavilions, thrones, etc.
 - 7.3.1. When a depreciable item is fully depreciated, it shall be deemed as a disposable item.
 - 7.3.2.If a depreciable item is lost, stolen, or damaged beyond repair, before it is fully depreciated, it may be replaced by consensus of the Baronage and the Financial Committee.
- 7.4. Disposable items are all other Baronial possessions.
 - 7.4.1.Disposable items may be disposed at the discretion of the Baronage, with the exception of items of historical interest (such as fully depreciated coronets.)
 - 7.4.2.Means of disposal may include, but are not limited to Baronial fundraisers, donations, or outright disposal.
 - 7.4.3. Any funds received from the disposal of such items must be put into the Baronial general fund.

Protectorate Treaty Between Nottinghill Coill and Border Vale Keep

....by Lord Etienne Le Mons d'Anjou

Exultation and joy mark this day of fifteenth of February in Anno Societatis LIV! Good gentles as we celebrate our shared accomplishments, hearken to these words as the Baronage of Nottinghill Coill and the Shire of Border Vale Keep, desirous of inaugurating a regular régime and recognition within Border Vale Keep based upon internal order and general security, making it possible to ensure the economic development and security of the Shire, have agreed upon the following:

Article I

The Baronage of Nottinghill Coill and the Shire of Border Vale Keep have agreed to establish in Border Vale Keep a régime admitting of the administrative, juridical, educational, economic, financial and military to support the Kingdom of Atlantia in all matters.

This régime shall safeguard the respect and traditional prestige of their Seneschal and Officers which shall not be infringed by the Baronage of Nottinghill Coill.

The Baronage of Nottinghill Coill will provide protection to the Shire as needed from neighboring states and will come to an understanding with these neighboring states regarding the interests which these states possess in virtue of their geographical position and territorial possessions.

In like manner, the Canton of Ritterwald shall retain the distinctive characteristics for which they have been known, regardless of their close geographic nature with the Shire, and which will determine their own organization.

Article II

The Seneschal and Officers of Border Vale Keep consent that henceforth Nottinghill Coill, after They shall have notified the Shire, may proceed to send troops through Border Vale Keep territory as They might deem necessary for the security of Their southern border and in defense of the Shire itself. These troops may move on land and within Border Vale Keep waters.

Article III

The Baronage of Nottinghill Coill pledges Themselves to lend constant support to the Seneschal and Officers of Border Vale Keep against all dangers which might threaten their persons, or endanger the tranquility of the Shire. The same support shall be given to the successors of these Offices.

Article IV

Such measures as the régime of the Shire may require shall be edicted by the Seneschal of Border Vale Keep or the authorities to whom he may have delegated his power. The same process shall be observed in the matter of new regulations and of modifications to the existing regulations.

Article V

The diplomatic and consular agents of Nottinghill Coill shall be charged with the recognition and protection of Border Vale Keep subjects and interests. To this end, the Baronage of Nottinghill Coill may extend honors normally reserved for Their own subjects to residents of the Shire.

The Seneschal of Border Vale Keep pledges themself not to conclude any act of an interkingdom nature without discussing the matter with Nottinghill Coill, thus maintaining the security of Nottinghill Coill's southern border.

Article VI

The Baronage of Nottinghill Coill and the Seneschal and Officers of Border Vale Keep reserve unto themselves to determine by mutual agreement the bases for a financial organization which, while respecting the rights conferred upon landholders of Border Vale Keep, shall make it possible to guarantee the engagements of Border Vale Keep treasury.

This agreement does not infringe upon the rights of the Kingdom of Atlantia and Their Majesties to issue dictates upon the Baronage of Nottinghill Coill or the Shire of Border Vale Keep. Both states are subordinate to the will of the Crown and Atlantian Kingdom Law.



Stained Glass 101 Part Three: Glass Cutting



Welcome to part 3 of my series on basic stained glass techniques. I apologize if this article is somehow lacking, as I am currently fighting bronchitis (this comment is period - there's marginalia where scribes apologize for their handwriting due to colds.) Also, cutting glass while my vision is swimming is... probably not my best plan ever, but we'll see.

At this point, you should have a viable pattern on tagboard, clearly labeled and ready to cut out. You want to use special scissors to cut it out. Pattern shears look like average scissor, but there are two connected outer blades, and an inner blade that removes the line between pieces. The center blades come in both foil and lead sizes. These shears will remove the perfect amount of paper to account for metal between your pieces. Theoretically, you can make your piece without

these, but it makes cutting and grinding far faster and

more accurate.




As you cut, make sure the shears are removing the


line. The shears are not always effective in this. If you don't remove the line now, you can end up having to re-grind the piece. Cleaning up your lines saves

When your pieces are cut out, assemble your puzzle, lest any have gone astray. (I had two pieces hiding in the folds of my pants.)

The cutting process is far better suited to in-person learning (the amount of pressure needed, physical techniques, just how far and fast a glass shard can fly), but I will attempt to explain the process anyway.


At this point, you need a glue stick. Glue stick adheres gently and quickly, washes easily, and can be rehydrated if the piece needs to be repositioned. I prefer the type that goes on colored and dries clear.





a lot of time in the long run.





There are several things to keep in mind when gluing your pieces. It is tempting to arrange all your pieces onto the glass at once, and here I show a perfectly valid arrangement. I could, in theory, glue everything down, cut the red lines first, and cut on the green lines once they were separated. However, glass doesn't always behave predictably, and the less often you have to remove and reposition pieces, the more peaceful your process will be. Instead, I suggest gluing pieces for one cut

at a time (or one cut on each end of the glass.)



This is how my glass went back out to the shop, with pattern pieces neatly arranged and ready to be glued when I get back.

An extremely important piece of equipment at this stage is safety goggles. Wear them any time you score, break, or grind glass.


You need a rigid surface that will allow glass dust and shards to fall away, preferably into a contained area. Waffle grids are the perfect solution. They come in 12"x12" sizes, and tend to have hinges that

allow you to connect multiple grids. I stick with one for my projects.

There are a few types of manual glass cutters. There is an oil-fed pistol grip cutter (perhaps the most common), a pencil-type oil cutter, a pencil-type dry cutter, and a basic dry cutter. All have a bit that can be made of diamond, tungsten carbide, or steel to score a cut on the face of glass. A dry cutter has several benefits, including a set of teeth for holding onto glass when breaking at cuts and a small ball for tapping near stubborn cuts. I prefer a pencil grip dry cutter, due to slight movement in the head (it helps lessen the impact of tremors from my hands), the larger size allows me to add more pressure than I can on



the more petite basic cutter, and there are no oil drips to contend with. (Also pictured above are grozer's pliers and plastic running pliers.)



With glass on waffle grid, eye protection in place, and small children and animals shooed from the area (my chickens are fascinated by glass work), you cut a score in your glass. Score only once, with steady pressure. Straight lines are best. Mild curves work as well. Sharp angles will lead to unpredictable breakage, which can waste glass and hurt you. The teeny tiny white line on the glass is a scored line. (I should have taken more pictures, but it isn't a very photo-friendly process, since it

features a lot of fine lines on shiny surfaces.)

Running pliers are useful for breaking long cuts. Here is the business end of

my running pliers. The ridge in the center bottom gets centered opposite the score line on the face of the glass. Gentle pressure usually gets the glass to snap in a controlled manner (depending on the glass.) You will use running pliers for a typical first round of cuts.





Grozers pliers are for snapping smaller cuts, or "snipping" edges. This is where your eye protection will be most useful. The grozers pliers can crush a piece of brittle glass before they grip, and the shards tend to fly freely. They also cut hours off your grinding time.

< This piece has been through 2 rounds of cuts but needs "snipping before it is ready. I tend to be cautious in my trimming, but I would rather spend a little longer grinding a piece than risk breaking my glass. After snipping it looks like this. >






Some problems you are likely to

encounter are hairline fractures, edges breaking unevenly, and straightforward breakage (uneven edges only matter if they go under your pattern piece.) Check your pieces as you go. Any type of breakage will require you to carefully wet the affected piece and remove your pattern piece. (One

piece in particular broke twice, and the pattern held up.)



Before you put away your cutting supplies, assembled your puzzle. This will prevent missing pieces and help you assess what pieces need snipping. I trimmed several white pieces, and found that one of my blue pieces had gone astray (risks of doing glass work while ill.) It had fallen on the floor and needed to be re-cut.

The next installment, grinding, will hopefully be a little more useful. It's also where a piece starts to come together.
