Baronial Seneschal: Request for Letter of Intent

With the announcement that our Baronial Seneschal Lord Vikerion Volkovich will become our next Baron, a successor for the role must be found. This is one of two mandatory positions within a chapter, the Exchequer being the other one. The Seneschal (at any level) serves as the chief legal representative/administrative officer; as such there are (or can be) real-world implications for your actions and the decisions your make.

There are a few requirements for becoming a Baronial Seneschal:

- You must be of legal age, in order to sign checks and contracts, serve on the Financial Committee, and make decisions legally.
- You must be acceptable to Their Excellencies and to the Kingdom Seneschal.
- You must complete the Seneschal 101 and 201 classes within the first 2 - 3 months after appointment.

Beyond these requirements, there are other considerations and traits which are beneficial, but not mandatory:

- Organized, and have room (electronic or hard-copyspace) for a variety of documents, both current and historical.
- o Discreet, and able to keep confidences.
- o Diplomatic/tactful.
- Able to make decisions, consulting other appropriate individuals as needed, and knowing when to pass things up the line, e.g. to the Kingdom Seleschal

- A decent communicator, who keeps the barony appropriately informed, including via "The Quill".
- Able to meet deadlines and due date for reports, and other situations.
- Accessible by phone, mail, and electronically (email).
- Responsive to others' needs and questions, even if you don't personally agree with the person or the issue.
- Able to manage, but not micro-manage.
- Aware of the rules and regulations: SCA, Atlantia, Nottinghill Coill.
- Flexible/adaptable: situations change, often abruptly, and you need to deal with them in a timely and appropriate fashion.

The position can, at times, be a challenge, but it also can be the most satisfying and gratifying one you'll ever hold.

If you wish to be considered for the position, please send a Letter of Intent via email to me (depsenscga@atlantia.org) with copies to Their impending Excellencies Lord Likerion (Reshtani@gmail.com) and Boiarynia Ceara of Novgorod (TrueFiberGeek@gmail.com), no later than Sunday, December 31st, 2023 (i.e. New Year's Eve).

The person chosen for the position will step into the job on Saturday, January 20, 2024, when Likerion is invested as Baron.
